BOOTH SPACE GUIDELINES:

All booth spaces must be pre-paid with this reservation form. **Exhibit space is outside.** There are a limited number of spaces available under a covered pavilion, it is first come first served so get your reservation fee in quickly. You must make your needs known in advance for electricity, which is an additional **\$15**. Electricity is available on a limited basis. **If you require 220v, power is limited to 50 amp circuits.** Cost is **\$50 for handmade arts & crafts booth, \$75 for non-food commercial booths and \$100 for food booths.** **NO DRINKS OF ANY KIND ARE ALLOWED TO BE SOLD BY VENDORS.** We will screen applicants and limit like vendors. If your application is denied, then your money will be refunded. Any items not listed may not be sold. Any reservations not in the best interest of the Vinita Area Chamber will be returned.

You may begin setting up Friday, Aug 27, at 10:00 am to 5:00 pm, and Saturday by 9:00 am.

All reservations must be prepaid. You must agree to follow all rules set by Craig County, City of Vinita, Vinita Area Chamber of Commerce, and the Craig County Fairgrounds. You agree to hold Craig County, Vinita Area Chamber of Commerce, and the Craig County Fairgrounds harmless from any and all claims, demands, and causes of action, liability damages, costs and expenses of any kind for loss of life, personal or bodily injury, or damage to property incurred by myself/my organization, employees, agents or servants incurred before, during or after the Annual Calf Fry Festival. Property and liability insurance is the responsibility of each exhibitor or participant.

We will be collecting sales tax the day of the event to be sent to the Oklahoma State Tax Commission.

Please provide the full dimensions of your trailer length including tongue; which side you serve from and any other information that might be helpful. You are responsible for providing any equipment needed: table, backdrop, cover, tent etc. Also, please remove your booth and clean area promptly after the Festival.
